WHAT CHALLENGES DO LEGAL TEAMS FACE?

8 in 10 corporate legal departments are **unprepared to support** their organizations' digital initiatives.

The **biggest challenges** for in-house legal departments include doing more with less (44%), appropriate use of technology (11%) and the speed of business (17%).

One of top problems legal departments face is **poor outcomes** (e.g., low productivity, high risks) due to limited process automation and increasing workload. But it is counted that 22% of a lawyer's job and 35% of a paralegal's job **can be automated**.

Document management (20%), contract life cycle management (18%), legal workflow automation (15%) are one of the most important areas where legal departments **do not currently have a solution** but are looking to procure.

Using technology to simplify workflow and manual processes is a **TOP 2 priority** for legal departments. Thus, 45% of legal departments report **increasing usage of legal technology**.

WHAT CAN HELP SOLVE CHALLENGES IN LEGAL DEPARTMENTS?

Technology is playing an increasingly important role in the delivery of legal services and the speed of technological change is one of the main threats that attract most concern for legal teams. With ever-increasing pressures on time and constraints on spend, they are asked to deliver more for less, faster. In addition, users' expectations of legal services are affected by a 24/7 mentality and digital availability.

As a result, in-house lawyers' responsibility to put the business first requires more effort and the technology can help this mission in alliance with improving user experience.

The more legal professionals can avoid spending time on less valuable work (the administrative, the routine, the low-skilled) the better. Any legal tech that saves legal professionals time through increased efficiency is inherently valuable and they more than almost any profession know the value of time. Technology can play an important role in improving the delivery of legal services through reengineering workflows to make them more efficient, and automating where possible, thus allowing lawyers to focus on the more strategic use of their time. Electronic signing therefore can help simplify and shorten document management processes, as well as guarantee data security and true legitimacy.
